Sonya makes a motion to approve up to \$1500 for the new security items, Cameras, Locks and doorknobs, 2<sup>nd</sup> by Slade, all approved, motion carried.
  - They met with the Brausen's, probably won't happen this year but we need permission from a couple landowners and they could probably work with them a little bit and make it better.



At 7:26 pm, Sonya moved to close the meeting, 2<sup>nd</sup> by Slade, all in favor, motion passed.


