The Board learned that the speed limits for Pine Center were being processed, with steps being taken by the Minnesota Highway Department and the County Engineer's office,

Building Permits for all of Crow Wing County will be investigated and issued by the Planning and Zoning Co-Ordinator's office instead of by the County Auditor's office. Mr. Gustafson, Planning and Zoning Co-Ordinator and his deputy Mr. Anderson has an office in the County Engineer's room and will be glad to talk to you and answer questions about Building and Sewer Permits.

The Board considered the legality of its purchasing land for the Camp Lake Public Landing. They voted continued maintenance, but tabled the matter of purchasing land pending further investigation.

The Board honored the Camp Lake Sportsmen's Association's petition (with over 100 signatures) by declaring their refusal to allow any more State land to be classified from Conservation to Non-Conservation.

The Board also agreed with the Camp Lake Sportsmen's Association's suggestion that "Pine Center" signs be erected at the four roads leading into Pine Center, also in Pine Center.

In order to eliminate uncertainties in multiple purchases or services, the motion was made and seconded that all bills to the Town Board should henceforward be paid from Statements or Invoices.
