

**ROOSEVELT TOWNSHIP
BOARD MEETING
August 11, 2025**

1. The meeting was called to Order at 7:00 pm by Chairman, Sonya Crocker, all officers present.

Sonya led the Flag Pledge.

2. Motion by Slade to approve the agenda as written, 2nd by Darla all approved, motion carried.
3. Motion by Sonya to approve July 14th, 2025, Board Minutes as written, motion was 2nd by Slade, all approved, motion carried.
4. Darla moved to accept the July Treasurer's report as read; 2nd by Sonya, all approved, motion carried.
5. Sonya moved to approve the claims as listed, motion was 2nd by Slade, all approved, motion carried.

5. Road & Equipment Report:

- Equipment: We have the new grapple on the tractor. Snowplow wing has been bent since we bought it. There was a guy that was supposed to come and look at it to get it straightened out.
- Roads: Need work, 2 different people 2 different ends of the township are concerned about the roads. Especially with winter coming up we need to make sure the roads are in good shape. It is a necessity of the Township to have good township roads. Jim says it would be very helpful if we can get the roads to a better condition. Sherry says on her end of the road there is lots of traffic on their roads so it needs to be maintained better. Slade said he has talked with Jacoby, but it is just not getting done. We are getting much more people up here in the area population is growing, roads are being used more.
- Jacoby is not going to be working for a while as he hurt himself on the job. His right knee is inflamed and workers comp has been submitted. He slipped in a washout on 8/8/2025 on Reddick Road and twisted his knee. No one was notified until Sunday at 6:07PM. Slade will make some time to work in the next couple of weeks. Maybe see if Ed wants to check roads for Slade. We do have a time clock now. Has it been verified what he has been doing. Garrison Township roads are not fully being done to good conditions, and Garrison is paying for us to do the job. Jacoby does have a 90 day review, would be roughly September 19, 2025.
- North Platte Lake – Speed Limit Resolution – Talk about having a posting of 25 MPH on the road. As the Crow Wing County Sheriff is the enforcement of these public roadways. We are waiting for Platte Lake Association to get back to us about how many signs they would like on the roadway. Slade makes a motion for having speed limit signs on these roads, 2nd by Darla, all approved, motion carried.
- Frontier Project #117398716 – Fiber optic needs to be ran under the road. An agreement to dig under road and put back to normal needed to be signed by Slade.

6. Open Forum:

- **Sonya – Township Garbage or Clean Up Day.** Slade said years ago when he was in High school they had their own garbage company and then recycling started. But then garrison disposal didn't want to do the monthly deal. Then people started throwing garbage in the recycling, and that was enough, and the township quit. No company wanted to come and pick it up because we are too far away. – A Fall and Spring clean up day. Maybe reach out to Casey Smude or Matt Benson with Roll Offs. Reach out to Platte & Richardson to see what they do for this day in their township – is there anything specific with this for government agencies.
