Jim says if you have a chance to get a warranty for that long it will be good. Slade makes a motion up to \$6000 to get the full extended 6 year warranty on the tractor, 2nd by Darla, all approved, motion carried.

No one came to discuss this issue.

Sonya made a motion to amend the claim to MN Unemployment Insurance we do not pay the check until after we talk to our Lawyer, 2nd by Darla, all approved motion carried.
- Down at the end of Bellview Nathan wants to put up a big gate on his grandma's land so no one will come up on the hill and ruin crops in their field. The neighbor John said he would put the gate up if he got township permission. We don't maintain it anyways, so no issue is seen. Just make sure it is back far enough so we can turn around. Darla makes a motion to

approve Nathan Nash to put a gate in at the end of Belview Road on his grandmother's property, 2nd by Slade, all approved, motion carried.

- Lyle brought up to Sherry about our meetings be posted online like Crow Wing County Commissioner Meetings. Maybe bring the community and more people would get involved online. Breanna will check into it.
